**Notice of Variation – extension of offer period

This is a notice given by Landbridge Energy Australia Pty Ltd ACN 168 060 366 (**Landbridge**) in  
relation to the offer dated 8 May 2014 made under the off-market takeover bid to acquire up to 100%  
of the ordinary shares in WestSide (**Offer**) pursuant to its replacement bidder's statement dated  
6 May 2014 (**Replacement Bidder's Statement**), as supplemented by a second supplementary  
bidder's statement dated 22 May 2014 and a third supplementary bidder's statement dated 3 July  
2014, and varied by the notices of variation dated 12 June 2014 (**First Variation Notice**) and 7 July  
2014 (**Second Variation Notice**), (together constituting the **Bidder's Statement**).

Capitalised terms which are not defined in this notice have the meaning given to them in the Bidder's  
Statement.

**1. Extension of Offer Period**

In accordance with section 650D of the *Corporations Act 2001* (Cth) (**Act**), Landbridge gives notice  
that Landbridge varies its Offer by:

- (a) extending the period during which the Offers will remain open so that the Offer will now  
close at 7:00pm (Brisbane time) on 5 August 2014, unless further extended or  
withdrawn; and
- (b) substituting the date "5 August 2014" for "22 July 2014" and replacing any references  
to the closing time with "7:00pm (Brisbane time)" in the 'Important Dates' table, the  
Chairman's Letter, Section 1, Section 9 and Section 10.5 of the Bidder's Statement (as  
varied), the Entitlement and Acceptance Form (as varied by the First Variation Notice  
and Second Variation Notice) and in all other instances where 22 July 2014 appears  
(or is taken to appear in place of "24 June 2014") as the last day of the offer period in  
relation to the Offer.

A copy of this notice was lodged with ASIC on 22 July 2014. ASIC takes no responsibility for the  
contents of this notice.
